Re: Lewis v Russe, et.al.

Dear Dr. Goodman:

The entitled matter has gone on for far too long without any decent purpose whatsoever. Your intransigence and recalcitrance in this controversy is not well taken. And your refusal to resolve this matter equitably is without good reason, conscience, or merit.

It has come to my understanding there are several documents testifying that you in your capacity as an EX OFFICIO has you listed as PRESENT at the COSEP of Meeting July 25, 1984, where I was pleading that I had not done anything worthy to be forced to repeat an entire freshman year at Rush While at the exact same time you and Russe amongst others allowed fellow freshman student Susan V. Crifase (now Dr. Susan Crifase-Lin) to knowingly receive extra makeup exams in direct violation of written school policy with full knowledge and consent of Henry P. Russe Dean was Rush Medical College," Susan Crifase received this unmerited favor and discriminatory treatment for her entire school studies till her graduation from Rush Medical College in 1988 the same year you listed me as graduating also in 1988, you knowing fully I was wrongfully dismissed on September 9th, 1985.

You, Dr Goodman on May 2, 2007 had changed the roster and record of students that were graduated from 1981-1991 that you altered that degree status under my name, from layman to M.D. along with seven other students after a mass public protest lead by my twin brother, Marcus Lewis on my behalf on May 1, 2007. This action would certainly be in violation of American Medical Association (AMA) and Licensing Committee for Medical Education (LCME) rules and would not appear in the AMA Master File.

Upon this revelation, I demand that you and Rush-Presbyterian-St. Luke's Medical Center, now Rush University Medical Center, settle this case, have your insurer, and re-insurer, Lloyd's of London and Swiss Re, pay by bank draft a sum of not less than \$22,425,000.00 plus local, state, and federal taxes due plus 15% interest compounded accruing since July 27, 2011, indexed for inflation (CPI) beginning with September 9, 1985, and put me back into medical school, fully reinstated, re-established, and restored, as a medical student in good standing, and supply a letter of recommendation for transfer to another United States medical school immediately.

You have stolen my life as a doctor, humiliated me and left me destitute as you parade yourself as some sort of visionary. I strongly beg to differ. Now the time has come to expose you and your entire educational institution for what you done to me and what you really represent.

But that can be alleviated by you coming to terms with me now by completely restoring me to being made whole as stated above thus avoiding the humiliation you personally will face before the public eye.

Refusal to do so will leave me no choice but to go and take this case to the mass media at once. You have fourteen (14) days from the date of this letter to ascent.
