Dear Dr. Goodman,

Today, 25 years ago, This university dismissed Martin Edward Lewis, thus stealing his medical career as a Clinical Neurosurgeon and barring his entry to another U.S. Medical School to complete his training. And why did you do it?

On May 1st, 2007, my group protested your medical school (Rush) to reinstate this man because you illegally gave white students in Martin's class in 1983 thru 1985 more make-up exams to ensure their forward progress unbroken, graduate and now practice their craft in medicine and Martin E. Lewis does not and is left behind because of you sir.

You, Dr. Goodman, I hold you personally responsible for this outrageous state of affairs concerning Martin Lewis, as you, Dr. Goodman, were present at COSEP meetings concerning Martin Lewis, knowing, he was innocent, forcing him to repeat his freshman year, take unnecessary make-up exams, having his grades changed from pass to fail and then allow him currently not to be made whole is simply treatment that signals you are cruel and barbaric.

I am still here to remind you and show you through these documents that you were there. You knew and on May 1st, 2007, I met you in your hallway outside your office and I presented your office with a settlement offer that Martin's life could be repaired in some small way so he could live out the life he would have at the level he aspired and would have succeeded at.
